



## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.UnbridledChange.org](http://www.UnbridledChange.org) and Unbridled Change and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Unbridled Change include [www.UnbridledChange.org](http://www.UnbridledChange.org) and UBC. The UBC website is a nonprofit organization site. By using the UBC website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

In order to better provide you with products and services offered on our Site, UBC may collect personally identifiable information, such as your:

- First and Last Name
- Mailing Address
- E-mail Address
- Phone Number

If you purchase UBC's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

UBC may also collect anonymous demographic information, which is not unique to you, such as your:

- Age

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

UBC collects and uses your personal information to operate its website(s) and deliver the services you have requested.

UBC may also use your personally identifiable information to inform you of other products or services available from UBC and its affiliates.

### **Sharing Information with Third Parties**

UBC does not sell, rent or lease its customer lists to third parties.



UBC may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to UBC, and they are required to maintain the confidentiality of your information.

UBC may disclose your personal information, without notice, if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on UBC or the site; (b) protect and defend the rights or property of UBC; and/or (c) act under exigent circumstances to protect the personal safety of users of UBC, or the public.

### **Tracking User Behavior**

UBC may keep track of the websites and pages our users visit within UBC, in order to determine what UBC services are the most popular. This data is used to deliver customized content and advertising within UBC to customers whose behavior indicates that they are interested in a particular subject area.

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by UBC. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the UBC website.

### **Security of your Personal Information**

UBC secures your personal information from unauthorized access, use, or disclosure. UBC uses the following methods for this purpose:

- SSL Protocol

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure. As a result, while we strive to protect your personal information, you acknowledge that: (a) there are security and privacy limitations inherent to the Internet which are beyond our control; and (b) security, integrity, and privacy of any and all information and data exchanged between you and us through this Site cannot be guaranteed.

### **Children Under Thirteen**

UBC does not knowingly collect personally identifiable information from children under the age of thirteen. If you are under the age of thirteen, you must ask your parent or guardian for permission to use this website.



### **E-mail Communications**

From time to time, UBC may contact you via email for the purpose of providing announcements, promotional offers, alerts, confirmations, surveys, and/or other general communication. In order to improve our Services, we may receive a notification when you open an email from UBC or click on a link therein.

### **External Data Storage Sites**

We may store your data on servers provided by third party hosting vendors with whom we have contracted.
